**N.B. 1. There will be three colored Nomination Form for three categories. Nomination Form will be White colour for General category, Yellow colour for SC/ST category and Pink colour for Women category. The Delegate member who collects the nomination form for the category should submit the nomination form for that category only. For example, Yellow or Pink coloured Nomination Form will not be accepted for General category.**

**2. Elected delegate from General category, belongs to SC/ST, can file Nomination for SC/ST category enclosing necessary caste certificate from the competent authority.**

**3. Nomination Form shall be supplied, on request, by the Returning Officer or any other officer authorized by him in this behalf, to any delegate member of S.E., S.E.C. & E.Co. Railway Employees' Co-operative Credit Society Ltd., free of cost from the Branch office as well as the Registered Office of the society.**

**4. Every Nomination Form shall be signed by two delegate members whose names are included in the list of the delegate members and one of the delegate members shall sign the Form as Proposer and the other as Secunder for the nomination.**

**5. Nomination Form with a certification of identity of the candidate, proposer and seconder by the concerned Railway Departmental/Sr. Personnel Officer/Bill Compiling Officer with designation and seal shall be presented in person by the candidate himself or by his authorised person whose name is in the delegate member list, to the Returning Officer or any other officer authorised by him on the date, time and place/venue specified for submission as per programme.**

6. Withdrawal of Nomination may be done by any candidate by notice in writing signed by him and delivered in person or by the person duly authorised by him within the date and time specified in the election programme for such withdrawal. Such notice shall also bear the certification of identity of the candidate by the concerned railway authority. The Notice of candidature given by the candidate shall be irrecoverable.
7. The Term of office of elected members of the Board and its Office Bearers shall be five years from the date of Election and the term of Office Bearers shall be co-terminus with the term of Board.
8. No Delegate is entitled to file Nomination for contesting in the B.O.D election as a Candidate if he / she has made any default in payment of any amount to be paid to the Society as on the date of filling the Nomination Form.
9. No Delegate who has been a member of the society for less than twelve months immediately preceding the date of such Election shall be eligible for being elected on the board.
10. No Delegate members of the society shall be eligible for being a members of the Board of the society if such members acquires disqualification as stated under Section 43 and 44 of the M.S.C.S. Act, 2002 read with 19J and 19K of the M.S.C.S. Rules, 2002.


