Sub: Availability of UPI Payment Facility through QR Code and Speaker Machine at Society Branches.

All concerned are hereby informed that, in pursuance of the decision of the Competent Authority, **UPI Payment Facility through QR Code along with Speaker Machine** has been made available at most of the Branches of the Society to facilitate **convenient, transparent and efficient receipt of payments** from members.

It is further informed that the **Branches where the aforesaid facility is not presently available shall also be provided with the facility shortly.**

Members may make payments, **within the prescribed procedural limits**, towards **New Membership, CMTD, Savings Deposit, Fixed Deposit, Recurring Deposit, Loan Repayment, Holiday Home Booking Charges** and such other permissible payments, as applicable, through the **official UPI QR Code displayed at the concerned Branch of the Society.**

The UPI facility shall be **in addition to the existing modes of payment** and shall be used only through the **official QR Code of the Society/concerned Branch** displayed at the Branch.

Members are advised to **verify the details displayed on the UPI application before confirming the transactions** and to retain the transaction receipt/UPI reference numbers for future record and verification, wherever required.

Payment through Credit Card shall not be accepted through the said facility.

All members are requested to **make use of the above facility for convenient, transparent and hassle-free payment to the Society.**
