**Reg: Intimation regarding extension of AC facilities at our Holiday Home Rooms at Haridwar & Puri.**

With a view to extend optimum benefit to the members of the Society, the management of the Society has already converted the 7 ( Seven) Non-AC Rooms to AC Rooms at our existing Holiday Home at Puri, situated at Hotel Indian, New Marine Drive Road, Near Gandhi Labour Foundation, Baliapanda, Puri, Odisha. with effect from 1<sup>st</sup> March, 2026.

It is also hereby informed that the management of the Society has decided to convert all the 7 ( Seven) Non-AC Rooms to AC Rooms at our existing Holiday Home at Haridwar, situated at Hotel Raj Deluxe, Vishnu Ghat, Haridwar with effect from 1<sup>st</sup> April, 2026.

Accordingly, it is hereby requested to the particular members who have already booked the rooms at Puri and Haridwar by depositing Rs.100/- through online or offline from 1<sup>st</sup> March, 2026 (For Puri) and 1<sup>st</sup> April, 2026 ( For Haridwar) onwards will now be required to deposit an additional amount of Rs.200/- to avail of such a facility. However, they may deposit such difference of booking amount either by physically at our branch offices immediately or to the said Holiday Home Authority before check-in to the booked room.

The system of bookings for availing of the Holiday Home facilities at Haridwar & Puri and the rules of booking thereof will be governed as usual under the existing procedure.

**Reg: Intimation regarding taking 6 (six) additional Holiday Home Rooms at Vellore.**
