Educational Assistance for the Children of Shareholders of the Society

The Competent Authority of the Society has decided to grant Educational Assistance for the Children of the Shareholders in the form of reimbursement of the cost of Books purchased for One Child only who studies in School/College/ University / Technical Institute. The actual amount of reimbursement per capita will depend on the fund available for distribution as well as the number of applications to be received from the shareholders for the purpose.

The above reimbursement is only for the Scholastic Year 2026-2027 i.e. for the period from April, 2026 to March, 2027 and will be allowed to the child **exceeding three years of age as on 01.04.2026.**

Applications for the above assistance from Welfare Fund of the Society in prescribed form (specimen attached herewith and also available at the Website of the Society) are invited from the Shareholders of this Society. The applications duly completed in all respects along with a legible **photocopy of the Bank's 1st page of Pass Book or a cancelled Cheque** (from which Name of the Member, Bank Account Number and IFSC can be verified) and forwarded by the Controlling Officer / Sr.Subordinate of the applicant should reach the respective Branch Office of the Society on or before **16th October, 2026.** Certification by School/ College/ University / Technical Institute Authorities as per format given in the prescribed application proforma is to be obtained. In absence of availability of such certificate, any documents in support of pursuing education in School/ College/ University/Technical Institute must be attached with the application form. For the convenience of members the payment of educational assistance will be made through NEFT / RTGS only. The applications which are incomplete or received after the last date will not be entertained under any circumstances.
