It is our pleasure to inform you that the Management of the Society has successfully launched online facilities through our new website (www.ubreccs.com) and the Mobile App "Parivartan" for the benefit of our shareholders. The digital platform was formally inaugurated during the 96th Annual General Meeting held on 13th September 2025 at Nagpur.

At present, shareholders are availing online services through the Parivartan Mobile App for Holiday Home bookings. We are now pleased to announce that, as approved by the Management of the Society, the online facilities for **Savings Deposit (SD)**, **Recurring Deposit (RD)**, and **Fixed Deposit (FD)** will go live on the Parivartan App with effect from **1st January 2026 to check the balances only; after 15 days** i.e. from 15th January 2026 shareholders can perform online transaction of SD, RD & FD, marking a new beginning in the New Year.

With the launch of these modules, our Society takes a significant step towards becoming a fully digitalized society in 2026. This initiative will enable our shareholders to access SD, RD, and FD services anytime and from anywhere in India.

Please note that the SD, RD, and FD data have been migrated from manual records to the online system, and the modules have been developed with user-friendly features for the convenience of our shareholders. We kindly request all shareholders to verify the balances of their SD, RD, and FD accounts as reflected in the Parivartan App as on **19th December 2025**.

Shareholders are requested to provide their feedback/any discrepancy regarding account balances or any technical issues/glitches in the Parivartan App to their respective branches or lodge a grievance in the grievance column within **15 days from the date of launch**. Step-by-step guidelines and video tutorials on how to use the SD, RD, and FD modules for deposits and withdrawals will be issued within **one week of the launch**.

As this is the first time the Society is introducing online SD, RD, and FD services, we sincerely seek the cooperation of all shareholders by sharing their valuable feedback with their respective branches to help us improve and streamline the system.

Please note that **online deposit and withdrawal transactions through the Parivartan App will be enabled from 16th January 2026 onwards**.

In addition to the above, a **zero-balance Savings Deposit (SD) account** will be generated for all shareholders who do not currently have a Savings Account with the Society. Shareholders may activate their accounts by submitting the required documents to arrange a **monthly contribution** to be deducted through a salary bill or by payment via the **online module**. However, a **minimum balance of ₹300/-** must be maintained in the Savings Account at all times.

We look forward to your continued support and cooperation as we move towards a more convenient and digital future.
