It is hereby notified for the information of all members that the Management of the Society has decided to implement the following provisions with effect from **1st July, 2026**:

1. Fixed Deposit (NS)

- Fixed Deposits under the **Fixed Deposit (NS)** shall be accepted only in multiple of **Rs. 1,000/-**, subject to a minimum deposit amount of **Rs. 10,000/- (Rupees Ten Thousand only)**.
- Interest at the rate of **6% per annum** shall be applicable under the **Fixed Deposit (NS)** for deposits having a tenure of **more than three (3) months but less than one (1) year**. In the event of any premature withdrawal, the existing applicable rate of interest as per the rules of the Society shall apply.

2. Savings Deposit

Members may deposit up to **Rs. 2,40,000/- (Rupees Two Lakh Forty Thousand only) per annum** in their Savings Deposit Account through either the online or offline mode. In addition, members may deposit an amount of up to **Rs. 10,000/- (Rupees Ten Thousand only) per month** through salary deduction. However, under the offline mode, an individual member may deposit a maximum of **Rs. 20,000/- (Rupees Twenty Thousand only) per transaction** in cash.

It is further notified, for the information of all members, that once a **standing instruction** has been submitted regarding the mode of deposit for **the Savings Deposit Account** and the amount of subscription to be deposited either in cash or by way of adjustment from the Savings Deposit Account towards **the Recurring Deposit Account** of the Society, **such standing instruction shall not be altered or modified within a period of six (6) months** from the effective date of the change made to the previously submitted standing instruction.

All other terms and conditions relating to the above-mentioned schemes shall remain unchanged.
