## **RULES**

1. The deposit may be accepted in single / joint name (s). For the deposits with joint names, the first depositor must be a shareholder of the society on the date of application and must continue as such during the tenure of the deposit.
2. For premature withdrawal, the same is to be governed by the rules and regulation as to be framed by the Board of Directors of the Society time to time.
3. The deposit shall be for a minimum period of twelve months or multiple thereof subject to maximum period of sixty months.
4. The Recurring Deposit shall be accepted only in cash through filling up of a deposit slip specified for this purpose.
5. The monthly deposits will be accepted for a minimum amount of Rs. 100/- and multiple thereof subject to maximum of Rs. 500/-
6. The deposits will not earn any interest from the date from which the first depositor loses the right of membership as per extant rules of the society.
7. Depositor(s) furnishing L T I on the Application Form must submit two copies of recent passport size self photograph.
