It is hereby informed to all concerned that as per Bye-law No.16(ii)(c) of the Society, each shareholder may additionally subscribe towards CMTD account in addition to his/her minimum monthly subscription with immediate effect and as per Bye-law No.16(ii)(e) of the Society, it has been now decided by the management of the Society to allow the shareholders to deposit a lumpsum amount maximum up to Rs.1.00 lakh through online/offline mode in maximum 4 installments in a financial year subject to maximum of cash deposit of Rs.10,000/- at a time. However, this will come into force after activation of the CMTD module.

In this connection, it is also informed that necessary modules in respect of Savings Deposit, Recurring Deposit and Fixed Deposit Accounts of the Society have already been launched and such facilities have been extended to the Shareholders of the Society through online service by our 'Parivartan App'/Website.

However, for opening of such Fixed Deposit and Recurring Deposit Account with the Society, the shareholders must maintain a Savings Deposit Account with the Society and to facilitate this, a Savings Deposit Account has already been generated with ZERO balance against each shareholder and that will be operative subject to deposit of a minimum amount of Rs.300/- only through online mode by the shareholders either in Parivartan App or Website. Offline mode is also available at their respective branches by submitting instruction to deduct from salary bills either by offline or online.

A Shareholder can also open Fixed Deposit Account by transferring the amount from his/her Savings Deposit Account through online or offline by applying regarding the amount to be debited from his existing Savings Deposit Account and to credit the same to that particular Fixed Deposit Account along with prescribed form duly filled in.
